We were founded in 1946 as an employee activity of the Glenn L. Martin Co. and, although our relationship with the company is no longer in effect, we still are active as an independent group. Many of our members have been active over the years in Civil Defense and Public Service Communications and in giving hands-on demonstrations to youth groups, especially the Boy and Girl Scouts.

We are writing this letter to express our concern about an article that appeared in the Baltimore Sun regarding the proposed closure of Essex Skypark on Diffendal Rd, in Essex. We respectfully urge you to help find a way to keep the skypark open.

Essex Skypark has been part of the Eastern Baltimore Community since 1943, only a few years prior to our own beginnings. It is an historic asset to our community and served as part of the war effort. Too many of the reminders of the history of Eastern Baltimore County areas are disappearing.

The present membership of the Essex Skypark Association has a mission that parallels our own. Where we promote the advancement of radio communications, the Skypark membership promotes and supports the advancement of private aviation. As with our group, the Skypark Association provides outreach to the local community. They open their facilities for use by scout groups and Civil Air Patrol.

The Essex Skypark remains the only public use airport in Baltimore County. The runway there provides a safe landing for distressed aircraft; a training facility open to use by law enforcement and first responders for air, land and sea rescue.
